SGAT Advice Notice No. 12

NEW MEXICO PUBLIC REGULATION COMMISSION

Qwest Corporation ("Qwest") hereby gives notice to the public and the Commission of the filing of Seventh Amended Exhibit A to Qwest's New Mexico Statement of Generally Available Terms ("SGAT"), Eleventh Revision. Seventh Amended Exhibit A is Qwest's price list for unbundled network elements and interconnection services provided pursuant to the SGAT. Seventh Amended Exhibit A is filed in compliance with the Final Order (the "Order") issued by the New Mexico Public Regulation Commission (the "Commission") on June 7, 2007, in Case No. 05-340-UT, and Qwest asks the Commission to permit Seventh Amended Exhibit A to take effect immediately pursuant to the Order. In compliance with Qwest's SGAT Review Procedures as approved by the Commission on December 16, 2003, in Case No. 003-00025-UT, Qwest provides the following information regarding this filing:

- 1. Seventh Amended Exhibit A is submitted with this Advice Notice. An additional copy of Seventh Amended Exhibit A is also submitted with the text marked and footnoted to show and briefly explain all changes and revisions to Sixth Amended Exhibit A to Qwest's New Mexico SGAT, Eleventh Revision. The two copies of Seventh Amended Exhibit A are labeled as Schedule A to this Advice Notice.
- 2. Seventh Amended Exhibit A incorporates the changes in prices and related terms required by the Order. Specifically, it incorporates the following changes:
 - a. In the Order, the Commission redefined the three zones applicable to those elements that are priced by zone. The wire centers included in each of the three zones are listed in Schedule B to this Advice Notice. Schedule B includes an additional copy of the list marked to show changes from the previously applicable zones.
 - b. Prices for those elements that are priced by zone are revised to comply with the Order.
 - c. Fixed recurring and per mile recurring prices for Direct Trunked Transport, Unbundled Dedicated Interoffice Transport, and Extended Enhanced Loop Transport are revised to comply with the Order.

d. Although inadvertently omitted from the price changes required by the Order, the prices for 2-Wire Nonloaded Loop when ordered with Port (without Grooming) (Section 9.2.2.2) are revised to conform to the prices for 2-Wire Voice Grade Loop when ordered with Port (Section 9.2.1.2).

Until it completes billing system programming necessary to implement the new zone pricing later this year, Qwest will charge the Zone 1 price for all elements that are priced by zone. The Zone 1 price is the lowest applicable price. When the system programming is complete, Qwest will begin billing Zone 2 and Zone 3 prices prospectively only and after notice to affected customers. Qwest is requesting a variance from the Order to implement the zone pricing in this manner.

- 3. Except for the requested variance, to Qwest's knowledge, the proposed changes reflected in Seventh Amended Exhibit A do not conflict with any order or rule of the Commission currently in effect.
