- Comprehensive, on-demand security audit that identifies, analyzes and reports on security threats to your Agency's systems, networks and applications
- Knowledge base of exploits updated daily from information provided through strategic relationships and a skilled staff of dedicated security engineers
- Scans and audits the majority of commercial and open source applications on more than 200 different platforms and operating systems
- Performs external scans by remotely probing a network for vulnerabilities that are exploitable from the Internet
- Performs internal scans using a scanner appliance that detects flaws that are exploitable from the inside of a network

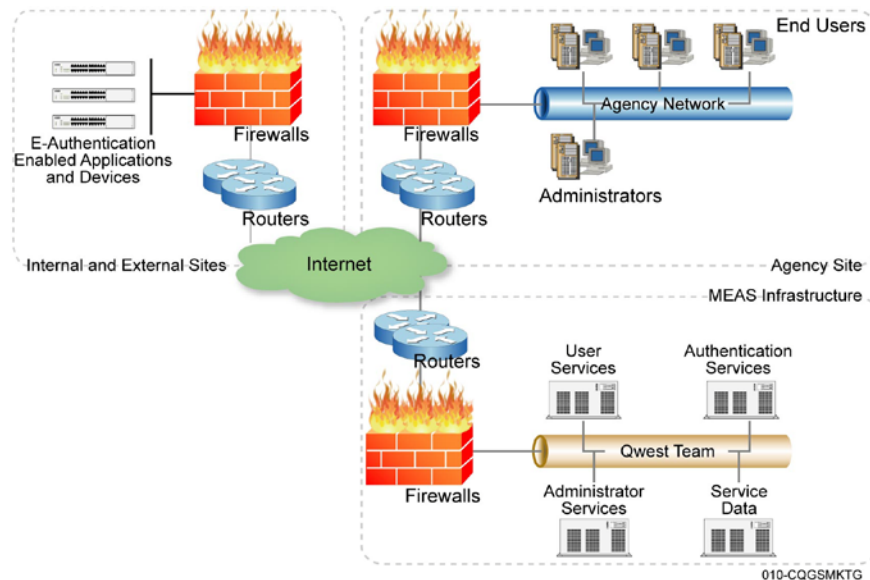
